V: NEW BUSINESS

1. Motion to approve the revised Board Policies – Supervisor

TREASURER PECK MOVED, supported by Trustee Almassy to accept the revised Board Policies.

The Board reviewed the entire Policy Manual making several revisions.

2. Motion to repair the sunroom roof of the Township Hall – Supervisor

TREASURER PECK MOVED, supported by Trustee McGrath to repair the sunroom roof of the Township Hall.

TREASURER PECK MOVED TO AMEND THE MOTION, supported by Trustee McGrath to authorize Good's Roofing to repair the sunroom roof of the Township Hall.

Supervisor Thorsby stated Good's Roofing had also given the Township a 10% discount.

3. Motion to approve the Fiscal Quarterly Budget ending September 30, 2017 – Treasurer

Treasurer Peck stated he had included, for the Board's information, a printout on the salaries for elected officials in Genesee County pointing out the Compensation Commission will be given this information for their meeting later this month.

TRUSTEE ALMASSY MOVED, supported by Trustee Westenbarger to approve the Fiscal Quarterly Budget ending September 30, 2017.

4. Motion to return Building Inspection and Code Enforcement to the Township – Supervisor Thorsby

Supervisor Thorsby stated action was needed in order to return Building Inspection and Code Enforcement to the Township regardless of who the Township chose.

TREASURER PECK MOVED, supported by Trustee Minarik to return Building Inspection and Code Enforcement to the Township.

The Board briefly discussed hiring an individual to serve as a Building Inspector or using the company, Safe Built. It was pointed out the Cities of Flushing and Montrose use this company and is satisfied with them. Supervisor Thorsby stated Safe Built would also help with the process of returning Building Inspection to the Township from the State. Supervisor Thorsby stated the Township would have to go the State Board that oversees returning Building Inspection to the Township and they only meet quarterly and it is quite an involved process.

There was discussion regarding Code Enforcement and it was pointed out Safe Built could also perform this responsibility. Trustee Westenbarger pointed out the enforcement was currently being done by the Police Department.

Trustee McGrath questioned what effect this would have on the Planning Commission and it was stated reports would be generated and shared with the Planning Commission.

Supervisor Thorsby also informed the Board of an improvement which was made at the Nature Park regarding the well and city water which should save about \$500.
- 2. Clerk's Report Clerk Meinburg stated the Township had met with the financial advisors today and was switching from Lord Abbett to John Hancock. The Federal Government has instituted new regulations which Lord Abbett isn't going to follow, so a switch to John Hancock was necessary and they also offer more choices.

- 4. Chief Fairchild gave the police report. Trustee Westenbarger noted the traffic citations had gone up.
