NEW BUSINESS

1. Possible Change in Labor Attorney

MINAUDO MOVED, seconded by Purkey that the Township Board hire the law firm of Fahey Schultz Burzych and Rhodes PLC for all labor and employment matters and that the Supervisor be authorized to sign the April 7, 2010 Engagement Letter prepared by the law firm.

DISCUSSION:

Per the Township Attorney, there are no requirements that the Township put out bids for professional services, and never was, for such as attorneys, auditors, and engineer. It was recommended that the new Attorneys get with Keller Thoma to get the update on the current lawsuits. It was recommended that Attorney Moulton contact Attorney Rick Fanning of Keller Thoma and take care of the Engagement Letter; Attorney Fanning will deal with the issues professionally. If the current grievances are in the early stage, it was recommended to transfer the case to the new law firm. If not, then Keller Thoma would continue with the case. It was felt that if the Township made a mistake in changing attorneys, we could change again.

The new law firm has taught classes at Michigan Township Association Seminars.

2. Genesee County Road Commission 2010 Dust Control Program

MINAUDO MOVED, seconded by Purkey to apply two (2) chloride applications which the Genesee County Road Commission (Road Commission) won't pay.

DISCUSSION:

There are normally three (3) applications of chloride, with the Road Commission paying for one (1) application and the Township paying for two (2) applications. Ron Lattimer, Foreman of the Road Commission, stated normally 2,000 gallons of chloride are used per mile; to save money, reduce the amount of chloride down to 1,500 gallons per mile. With each chloride treatment, a new scrape is done. In the past, the Township has only paid for one (1) chloride application. There are only eleven (11) miles of gravel road in Flushing Township. The Supervisor authorizes the work to be done and the foreman puts in the request into the Road Commission.

Most townships throughout Genesee County only get two (2) spreads of chloride.

AMENDED MOTION:

MINAUDO MOVED, seconded by Noecker to apply three (3) chloride applications as follows:

<u>First Application</u>: 2,000 gallons and the Road Commission would pay. <u>Second Application</u>: 1,500 gallons and the Township would pay. <u>Third Application</u>: 1,500 gallons and the Township would pay.

3. Resurfacing of Morrish Road, Deland Road, and Johnson Road

MINAUTO MOVED, seconded by Purkey to gravel Morrish Road for \$46,000.

DISCUSSION:

The ditching would be done after the gravel is placed on Morrish Road. The request to the Road Commission is as follows:

- a. Gravel Morrish Road from Mt. Morris Road to Frances Road.
- b. There would be four (4) inch loose stone; and three (3) inches compacted stone; it was recommended to go with the four and three inches.
- c. The crown of the road would be elevated more to bring it up.
- d. The cost would be \$46,000 for one (1) mile of gravel.
- e. Each train load hauls fifty (50) to fifty-two (52) ton.
- f. Every time stone is put on a road, chloride is also put down. (2,000 gallons is used at 52 cents per gallon). The chloride will keep the stone in place and the dust down.

DELAND ROAD:

MINAUDO MOVED, seconded by Purkey to use 50/50 monies for ditching on Deland Road between Stanley Road and Coldwater Road.

DISCUSSION:

The township's 50/50 money is used first and then the ten (10) days of free ditching is used. Is there some type of program to get both sides of the ditches cleaned out and at the same time kill the saplings, cattails, etc along the sides of the ditches to make the water flow better. Would the process work out or would it be useless.

The Road Commission has a mowing system where, on the local roads, they make one (1) pass down the road one (1) time a year; the primary roads, two passes are made two times a year; the State roads have the same system as the primary roads. The ditches are for the water from the road to flow. A list of ditching jobs will be given to the foreman.

Deadlines go through the Construction Department as they have to let bids out; maintenance schedules the event and it is put on the calendar. If the township decided to use the 50/50 money for paving for Deland Road, the money has to be used up by September 30, 2010. The signed contracts have to go to the Road Board.

4. <u>Mid Michigan Maintenance – Manhole Contract and Pumping Station</u> <u>Located Behind Flushing County Park</u>

GARDNER MOVED, seconded by Purkey to approve an auto dialer at pumping station number 103 (Flushing County Park – Carpenter Road).

DISCUSSION:

Mid-Michigan Manufacturing Inc. is in the fourth of a five year contract. They take care of the manholes and the pumping stations in Flushing Township. The pumping station by the Flushing County Park (Carpenter Road) does not have an alarm on it so when the power goes the neighbors call when they see water running down the street or basements. An auto dialer is needed at pumping station number 103.

It was also requested by Mid-Michigan to place limestone inside the chain link fence to keep the area dry. The limestone will be donated.

NOECKER MOVED, seconded by Minaudo to sell the wench, roller, lawn sweeper, one lawn mower and one cycle bar mower. A minimum bid should be placed on the wench.

DISCUSSION:

The government (Road Commission) puts items on a government web listing. It was advised to check with John Bennett of the Road Commission. The specific items are no longer being used by the Township. It was recommended to try E-Bay or Craig's List but recommended by Michigan Townships Association (MTA) to not put the item on E-Bay. The issue will be checked into and then referred to board members.

6. Opening of Bids for 1998 GMC Sierra Pick Up

The township could put the item up for bid again in the future but it was decided to put the item on the list with the wenches. As a courtesy, it was recommended to contact the person that bid on the truck.

7. Opening of Bids for 2010 Lawn Care Service

PURKEY MOVED, seconded by Matzke to go with Elite Lawn Care at \$50 per week for the lawn mowing at the township hall.

Four (4) bids were received: Donaldson & Son at \$60; Elite Lawn Care at \$50; Becks Lawn Care Service at \$55; and J & M Tree Service at \$70
