WHEREAS, following foreclosure for nonpayment of real property taxes, the Charter Township of Flushing has acquired from the Genesee County Treasurer, title to the following properties:

WHEREAS, the Township Board of Trustees believes it would be appropriate to authorize the Supervisor to sign, on behalf of the Township, any and all documents necessary to effect sale or other transfer the properties as stated above;

IT IS HEREBY RESOLVED:

- 1. The Supervisor, Clerk and Treasurer are hereby authorized to act on behalf of the Township to negotiate, as they deem appropriate, the sale or other disposition of the above listed properties.
- 2. The Supervisor is hereby authorized to sign, on behalf of the Township, any documents reasonably necessary to provide for the sale or other disposition of the properties, including, but not limited to, listing agreements, contracts for appraisals, requests for title insurance, purchase agreements, leases, land contracts and deeds.
- 3. This Resolution provides full authority to the Supervisor, Clerk and Treasurer to deal with the above-referenced properties and no further approval of this Board shall be necessary to effect sale or other disposition of the above referenced properties on behalf of the Charter Township of Flushing.
