A RESOLUTION TO AUTHORIZE CONTRACTING WITH THE GENESEE COUNTY ROAD COMMISSION FOR THE REPAIR OF ONE (1) CATCH BASINS IN PONDEROSA

WHEREAS, the Genesee County Road Commission has determined that one (1) Catch Basin located in Ponderosa, identified below, are in need of repair; and,

WHEREAS, it would be prudent to effect repairs to the catch basin; and,

WHEREAS, the cost for repair of the Catch Basin is to be allocated equally between the Township and the Genesee County Road Commission;

#### IT IS HEREBY RESOLVED:

1. The Charter Township of Flushing is authorized and shall enter into a contract with the Genesee County Road Commission for repair of the

following Catch Basin, with the scope of the work to be determined by the Genesee County Road Commission:

- (A) One (1) catch basin at Tahquamenon Trail and Chickasaw Trail
- 2. The Township Supervisor and/or Clerk are authorized to sign, on behalf of the Township, contracts or work orders to be prepared by the Genesee County Road Commission to provide labor and material for the repair of the above identified catch basin.
- 3. The total cost to be allocated under the contract to the Township for the repair of the Catch Basin shall be 50% of the actual cost of repair and shall not exceed \$2,800 for the Catch Basin, as set forth in the Catch Basin Cost Estimate which is attached and incorporated as part of this Resolution.
- 4. Authorization is granted for the Township's expenditure of an amount not to exceed \$2,800 for repair of one Catch Basin to be allocated to such budget line item as the Board determines.

A RESOLUTION TO AUTHORIZE CONTRACTING WITH THE GENESEE COUNTY ROAD COMMISSION FOR THE REPAIR OF FOUR (4) CATCH BASINS IN THORNRIDGE SUBDIVISION

WHEREAS, the Genesee County Road Commission has determined that four (4) Catch Basins located in Thornridge subdivision, identified below, are in need of repair; and,

WHEREAS, it would be prudent to effect repairs to the catch basins; and,

WHEREAS, the cost for repair of the Catch Basins is to be allocated equally between the Township and the Genesee County Road Commission;

#### IT IS HEREBY RESOLVED:

- 1. The Charter Township of Flushing is authorized and shall enter into a contract with the Genesee County Road Commission for repair of the following Catch Basins, with the scope of the work to be determined by the Genesee County Road Commission:
  - (A) Two (2) Catch Basins at 7473 Fieldstone
  - (B) Two (2) Catch Basins at 3243 Fieldstone
- 2. The Township Supervisor and/or Clerk are authorized to sign, on behalf of the Township, contracts or work orders to be prepared by the Genesee County Road Commission to provide labor and material for the repair of the above mentioned catch basins.
- 3. The total cost to be allocated under the contract to the Township for the repair of each Catch Basin shall be 50% of the actual cost of repair and shall not exceed \$2,800 per Catch Basin or a total of \$11,200 for all four (4) Catch Basins, as set forth in the Catch Basin Cost Estimates which are attached and incorporated as part of this Resolution.
- 4. Authorization is granted for the Township's expenditure of an amount not to exceed \$11,200 for repair of the four (4) Catch Basins to be allocated to such budget line item as the Board determines.
