# **Genesee County**

Mass Transportation Authority Millage Renewal Proposal

Shall the current Mass Transportation Authority Millage, set to expire in 2024, which has been reduced by the required rollback to 1.2095 mills, be replaced and increased to the original amount of 1.225 mills (\$1.225 per \$1,000 of taxable valuation) upon the taxable valuation of the property within Genesee County, as finally equalized, for a period of five years from 2025 - 2029 inclusive for the purpose of providing mass transportation services Including demand response ("Your Ride") and other related services for the elderly, persons with disabilities, the disadvantaged and other members of the public throughout Genesee County.

Senior Services Millage Renewal Proposal

Shall there be a renewal of the previously approved authorization of the Genesee County Board of Commissioners to levy a tax of 0.6852 mills (\$0.6852 per \$1,000.00 of taxable property valuation) upon the taxable valuation of property within Genesee County, as finally equalized, for each of the ten (10) years from 2026 through 2035, inclusive, for the purpose of supporting services for citizens 60 years of age or older?

Proposition for 9-1-1 System Funding

Shall the County of Genesee, Michigan, be authorized to assess a charge on all landline, wireless, and voice over the internet protocol service users located within Genesee County of \$3.00 per month for each of the five (5) years from 2025 through 2029, inclusive, to be distributed exclusively for funding of 9-1-1 emergency call answering and dispatch services within Genesee County including facilities, equipment, maintenance, and operating costs?

## **Atlas Township**

Recreation Pathways Millage

Shall Atlas Township replace the previously approved .125 mill that expired in 2023, which had been reduced to .1195 mill by required millage rollbacks, with an increased levy of .125 mill (\$ .125 on each \$ 1,000.00 of taxable valuation) for a period of five (5) years, 2024 to 2028 inclusive, for the construction and maintenance of recreational pathways, which will raise an estimated \$ 56,625.00 in the first year the millage is levied.

#### **Clayton Township**

Swartz Creek Area Fire Department Millage

Shall the Charter Township of Clayton levy up to 0.8 mills against the taxable property within the Charter Township of Clayton commencing on December 1, 2024, for a period of 5 years raising up to an estimated \$208,539 in the first year the millage is levied? The purpose of this levy is to provide funding for the purchase of fire department vehicles for the Swartz Creek Area Fire Department.

### Flint Township

#### Fire Safety Protection Equipment Millage Renewal

Shall the previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution within the Charter Township of Flint, Genesee County, Michigan, of .25 mills, which millage increase will expire in 2025, be renewed for said Township in an amount not to exceed .25 mills (\$0.25 on each \$1,000 taxable value), against all taxable real and tangible personal property for a period of five (5) years, 2026 to 2030, inclusive to provide revenues for the purchase of equipment and rescue suits for the Township's Fire Department?

#### Road Millage Renewal

Shall the previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution within the Charter Township of Flint, Genesee County, Michigan, of .50 mills, which millage increase will expire in 2025, be renewed for said Township in an amount not to exceed .50 mills (\$0.50 on each \$1,000 taxable value), against all taxable real and tangible personal property for a period of ten (10) years, 2026 to 2035, inclusive to provide funds for road maintenance and improvement?

#### **Montrose Township**

#### Emergency Vehicle Millage

Shall a newly created voted property tax levy be approved on 8-6-2024 of 1.000 mills (\$1.000 per \$1,000 of taxable value) and levied against the taxable value of real and personal property for up to ten (10) years, 2024 through 2033 inclusive, raising an estimated \$178,581.16 in the first year for emergency vehicle purchases for the Montrose Township Fire Department.

#### Fire Equipment Millage Renewal

Shall the previously approved extra voted property tax levy be expiring on 12-31-2024 of 0.4670 mills (\$0.4670 per \$1,000 of taxable value), and since reduced to 0.4534 mills (\$0.4534 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at 0.4534 mills (\$0.4534 per \$1,000 of taxable value) and levied against the taxable value of real and personal property for up to six (6) years, 2025 through 2030 inclusive, raising an estimated \$80,968.70 in the first year for the operation of the Montrose Township Fire Department.

## Police Operating Millage

Shall the previously approved extra voted one mill (\$1.00 per \$1,000 of taxable value) that expires on June 30, 2024, and since reduced to 0.9821 mills (\$0.9821 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at 0.9821 mills (\$0.9821 per \$1,000 of taxable value) to be levied against the taxable property within the City of Burton for a period of 20 years for the purpose of providing funds for operation of the Burton Police Department raising an estimated \$793,318.71, to commence September 1, 2024, after the existing extra voted police millage expires?

Sinking Fund Millage Proposal Shall the limitation on the amount of taxes which may be assessed against all property in Byron Area Schools, Shiawassee, Livingston and Genesee Counties, Michigan, be increased by and the board of education be authorized to levy not to exceed 3 mills (\$3.00 on each \$1,000 of taxable valuation) for a period of 5 years, 2025 to 2029, inclusive, to create a sinking fund for the purchase of real estate for sites for, and the construction or repair of, school buildings; for school security improvements; for the acquisition or upgrading of technology; for the acquisition of student transportation vehicles; for the acquisition of parts, supplies, and equipment used for the maintenance of student transportation vehicles; for the acquisition of eligible trucks and vans used to carry parts, equipment, and personnel for or in the maintenance of school buildings; for the acquisition of parts, supplies, and equipment used to maintain such trucks and vans; and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2025 is approximately \$850,368?
