#### A RESOLUTION TO HOLD PUBLIC HEARING TO CONSIDER LEVY OF CURRENT MILLAGE RATES

WHEREAS, the electors of the Charter Township of Flushing approved .5 mills for general operations and 3.4114 mills for police operations; and,

WHEREAS, for 2015, .5 mills was levied for general operations and 3.3884 mills was levied for police operations; and,

WHEREAS, for 2016, the millage rates, as rolled back by Genesee County Equalization are respectively .4876 mills and 3.2968 mills; and,

WHEREAS, the Board desires to hold a public hearing to consider levying for 2016, the millage rates levied in 2015, .5 mills for general operations, rather than .4876, as rolled back, an increase of 2.48%, or .0124, and 3.3803 mills for police operations, rather than 3.2968, as rolled back, an increase of 2.53%, or .0835 mills;

Notice of Public Hearing on Truth in Taxation Tax Calculations And Return Millage Rates To Pre-Rolled Back Rates

The Charter Township of Flushing will hold a public hearing to return its general fund operating levy to .5000 mill from .4876 mill, the rate rolled back by Genesee county equalization. The difference is .0124 mills or 2.48% and returns our authorized mill to .5000 mill. The township is authorized to levy 1.0400 mills.

The township proposes to levy 3.3803 mills on the authorized 3.4114 mills approved for police operations. The present rate of 3.2968 mills, as rolled back by Genesee county equalization, if returned to 3.3803 mills, will represent a change of 2.53% or .0835 mills.

The Truth in Taxation hearing will be held at the regular township board meeting on September 10, 2015 at 7:00 p.m., to be held at the Flushing Township Hall, located at 6524 n. Seymour road, Flushing, Michigan.

**WHEREAS**, Section 24e of the General Property Tax Act, MCL 211.24e, requires the Township provide for the holding of a public hearing for the levying of millage rates for its ensuing fiscal year; and

**THEREFORE, BE IT RESOLVED** by the Township Board of Flushing Charter Township, Genesee County, Michigan, as follows:

1. This resolution shall be known as the "Flushing Township 2016 Millage Levy Authorization", adopted pursuant to MCL 211.24e(3);

2. The Board shall cause to be levied and collected the general property tax on all real and personal property within the Township upon the current tax roll at an allocated millage of .5 mills for Township operations along with voter authorized millage of 3.3803 for police purposes.

3. The published notice setting forth the authorized millage rates; the millage rates as rolled back by Genesee County Equalization; and the differences between the roll back rates and authorized millage rates is attached and incorporated as part of this Resolution.

**TRUSTEE MATZKE MOVED,** supported by Clerk Morford to authorize the Chief of Police to spend up to Five Thousand Dollars (\$5,000) for the purchase and installation of an interior and exterior audio/video security system for the township office. The audio/video security system will not be used until the Flushing Township Board and the Teamsters Union develop a policy regarding placement and usage of cameras and access to the data, mutually agreed upon. The video/recording system will be maintained in the police department by the Chief of Police or his designee.
