UNFINISHED BUSINESS:

1. Recreational Alliance with City of Flushing, Flushing Community Schools and Flushing Township

PURKEY MOVED, seconded by Morford to approve the Recreational Alliance with five (5) year Flushing Area Recreation Plan

DISCUSSION:

Per the information from City of Flushing Business Manager Dennis Bow, the plan has to be reviewed every five (5) years. In order to obtain grants for the municipalities, there has to be a Five Year Flushing Area Recreation Master Plan.

In 1976 the State of Michigan leased property in the Pigeon River Area; twenty-five (25%) percent of the funds were put into a Trust Fund from which the grants are

received drawn. Communities across the state can competitively apply for the grants as long as the items (ball diamonds, schools, parks, etc) are listed in the Master Plan.

Flushing Area Recreational Committee Meetings are held and consist of two (2) representatives from each of the three (3) municipalities on the Recreational Committee. Rowe Inc is the developer of the Master Plan; Flushing Township's share would be approximately \$540.00 per year.

There was discussion regarding trails going through the property owners' back yard. It was debated that if the township didn't kick in and approve the Recreation Plan, Flushing Township might miss out on something that we really need.
