WHEREAS, the Supervisor has requested clarification of Resolution No.15-21 and the Board of Trustees believes the resolution Restricting Supervisor's Authority should be amended as stated below;

IT IS RESOLVED:

The Resolution Restricting Supervisor's Authority adopted August 13, 2015, is amended as follows:

1. Paragraph 3 of the Resolution is amended, in its entirety, to state:

The Supervisor and the Deputy Supervisor shall not be present at the Township offices from 8 AM-6 PM, Monday-Thursday, and shall only be present as reasonably necessary to conduct the limited duties reserved to the Supervisor under the Michigan Constitution and statutes, including voting on matters presented to the Township Board; chairing the meetings of the Board of Trustees; and, serving as the Township's designated agent for service of process. Except as expressly amended as stated above, all provisions of the Resolution adopted August 13, 2015, remain in full force and effect.

2. The Township's Police Chief is designated as the Township's emergency manager and in this capacity shall report to the acting Township superintendent. The Police Chief shall fulfill the obligations of the position of Emergency Manager, without additional compensation.
