#### V: NEW BUSINESS

1. Motion to adopt an Ordinance 17-3 to amend sections 5-26 through 5-32, inclusive, of the code of ordinances to allow the township to assume responsibility for the administration and enforcement of the Stille-Derossett-Hale single state construction code Act, 1972 PA 230, MCL 125.1501, et seq., as amended; and to authorize the township to designate a qualified agent to discharge such responsibility – Supervisor

**TREASURER PECK MOVED,** supported by Clerk Meinburg to adopt an Ordinance 17-3 to amend sections 5-26 through 5-32, inclusive, of the code of ordinances to allow the township to assume responsibility for the administration and enforcement of the Stille-Derossett-Hale single state construction code Act, 1972 PA 230, MCL 125.1501, et seq., as amended; and to authorize the township to designate a qualified agent to discharge such responsibility.

The Board briefly discussed with Attorney Moulton the process of returning the township to its own building inspections and code enforcement. Attorney Moulton stated this would be considered the first reading of the ordinance and once it is adopted, it has to be published or made available at the township office. Supervisor Thorsby stated the appointment with the State for the return of the building inspection function is January 14, 2018.

#### THE MOTION CARRIED UNANIMOUSLY.

2. Motion to approve contract with Safe Built to assume the responsibility for administration and enforcement of building inspections for the township - Supervisor

**CLERK MEINBURG MOVED,** supported by Trustee Westenbarger to approve the contract with Safe Built to assume the responsibility for administration and enforcement of building inspections for the township.

Supervisor Thorsby stated the City of Flushing is using Safe Built and is satisfied with their work. There was further discussion regarding the initial outlay of approximately \$15,000 for the necessary software. Our Assessor would also have access to this software which would enable him to be able to see improvements to property in the township.

**CLERK MEINBURG MOVED TO AMEND THE MOTION,** supported by Trustee Westenbarger to become effective with the adoption and second reading of the ordinance.

Discussion where to purchase the tables and chairs ensued along with the types of carts to use for storage purposes.

The general consensus was not to penalize someone from missing a meeting unless it was becoming a habitual problem.

5. Closed Session – opinion of Attorney Moulton regarding a tax tribunal case

The tax tribunal case in question was now public knowledge, therefore, this item was discussed in open session.

Attorney Moulton informed the Board of the tribunal's decision in regards to Hyde Park non-profit 5013C and the ramifications it would have on the township and police department as far as property taxes were concerned. It was stated approximately \$500 reimbursement from the township and \$3,400 from the police department. Attorney Moulton stated he would look into the mechanics of how to refund the money with the County.

**TRUSTEE MCGRATH MOVED,** supported by Trustee Almassy to approve reaching a settlement to refund the amount of taxes paid, plus the statutory interest rate.
