The board having conducted an extensive review of the qualifications of a number of spective police chief candidates and having narrowed that group down to three (3) and having conducted interviews at the open meeting last week may be in a position to select one of the three candidates as an individual the township may wish to conduct further discussion in hopes of reaching an agreement with that individual to serve as the township's police chief.

On Behalf of the Board, the possible selection of one of the individuals is a candidate they wish to proceed with is not going to be by that action alone, establishing an employment relationship between the township board and that candidate.
