CONTINUATION OF 1-a. Solid Waste Services

Representatives from three (3) solid waste services gave their presentation. Present was 1) Gary Hicks from Republic Waste, 2) Joe Denzek from Waste Management, and 3) Dan Garmen from Richfield Waste . In order to make it fair for all the representatives, a number was given to each representative. Trustee Matzke read the number and Supervisor Peck showed the number to the Clerk for recording the number

for each representatives: No. 1 – Dan Garmen; No. 2 – Gary Hicks; and No. 3 - Joe Denzek. The order of presentation was No. 2, No. 1, and No. 3. After the presentation, the Board had an opportunity to ask questions.

PURKEY MOVED, seconded by Minaudo to accept Richfield's Waste bid for solid waste pick up and management for Flushing Township subject to the parties reaching a mutual accepted contract and incorporating the bid specifications.

DISCUSSION:

It was suggested by the township attorney that the motion be to accept the bid subject to the parties reaching a mutual accepted contract and incorporating the bid specifications.

The bid price for the three (3) entities were as follows: 1) Republic Waste = \$418,110.00; 2) Richfield Waste = \$417,150.00; and 3) Waste Management = \$460,020.00.

All three (3) companies are very reputable. Richfield Waste Services will provide on a weekly basis: recycling, yard waste pickup, and large equipment and building supplies can be placed by the road on trash pick-up day. Additional free items that will be provided are: free monthly dump passes, extra dumpsters for the community, and leaf pickup to the subdivisions, as in the past.

The bid proposal contained a clause to where the township, at its sole discretion, would be able to terminate services with Richfield Waste within a sixty (60) day notice.

The waste pick up cost for Flushing Township for 2010 was \$531,060.00.

1-e. AND 1-g WERE DISCUSSED AS ONE ISSUE:

1-e. Seasonal Maintenance Personnel for Flushing Township Nature Park

The supervisor would like to hire two (2) Seasonal employees from now to November 11, 2010 to work at the Flushing Township Nature Park (Nature Park). Per the Teamsters Union Contract, the procedure would be allowed for up to six (6) months upon notification of the Teamsters.

The grant, received from the Genesee Regional Chamber of Commerce, would not allow the students to use power equipment so some of the projects that needed to be done could not be completed.

As long as the procedure met the Policies and Procedures Manual, nothing needed to be done, but if not, then changes needed to be made.

1-g. Consideration for Hiring Administrative Secretary for Police Department

Attorney Moulton discussed the *Policies and Procedures Manual* regarding the process to fill the position of Police Secretary. The *Policies and Procedures Manual* (Pages 17 and 18) requires the position be posted and published; the Township Supervisor, as the Personnel Officer, 1) would review the applications for the position; 2) screen and recommends the best candidate to the Personnel Committee for interviews, 3) the Committee selects the best candidate and then 4) presents the applicant to the Board for possible employment. The procedure is governed by the *Policies and Procedures Manual* and is not State Law and could be overridden.

The *Policies and Procedures Manual* makes reference to the Police Chief selecting the Police Officers but not the Police Secretary. The Attorney felt the Police Chief should have input into selecting the Police Secretary.

Currently, a procedure needed to be discussed as to how to fill the position. It was recommended to place the issue in the *Policies and Procedures Manual* so that the Chief and the Supervisor have the authority to hire.

NOECKER MOVED, seconded by Morford to accept the three (3) positions as stated. (The positions will be for two (2) seasonal employees at the Flushing Township Nature Park and one Police Secretary).

DISCUSSION:

The Police Secretary position will be on a part time basis. The new applicant will be on a three (3) month probationary basis at the pay rate of \$12.00 per hour. At the end of three (3) months, the issue will come back to the Board for final approve to hire on a part time, at will basis (from 8:00 a.m. to 1:00 p.m.) and the pay rate will be set at that time.

There is one remaining *Parks and Recreation Committee* Meeting for 2010. The Supervisor's goal will be to have individuals responsible, on a daily basis, for different areas of the park such as equipment, buildings, flowers/gardens, keeping paths trimmed, etc.

It was discussed who could and could not be on the Committees as there have been several volunteers that would like to be on the *Parks and Recreation Committee* and have been turned down. The Supervisor felt there should not be two (2) close relatives on the same committee. The next *Parks and Recreation Committee* Meeting will be held in October.

Since the 2011 Committee Appointments will be made in December, the Supervisor would like input from the whole board.

The project will be on a yearly basis. It was suggested to delete the permit issue. It was determined the issue will be reviewed at the end of the year as to the progress.

The cost to maintain the Flushing City Cemetery is a 50/50 project between the City and the Township. In the past the Township and City residents received a discount when they purchase cemetery lots or had a funeral. This year the City changed the rules so everyone will be paying \$700.00 for lots. It was determined there wouldn't be any advantage for the township to help pay for the maintenance since the township residents wouldn't receive a benefit. The township will pay the bill that is currently owed by the township.

1. Treasurer's Report:

- a. **PURKEY MOVED**, seconded by Minaudo to accept the Treasurer's Report. **MOTION CARRIED**.
- b. The Township sold the house on Frances Road which was received from the Genesee County Land Bank, for \$7,829.00. Due to the foreclosure issue, the township had to go through a Title Company in California to get the matter resolved.
- c. A \$2,500.00 bid was received to remove nine (9) inches of dirt from the two (2) indentations adjacent to the Township Office. The bid was for removal of the dirt and replace with three (3) inches of asphalt so the joints would be professional. It would make room for six (6) additional parking spaces.

BOARD COMMENTS:

- 1. **NOECKER** felt it would be a better to wait on the vacant appointment to the *Parks and Recreation Committee* since there is one (1) remaining meeting.
- 2. **MORFORD** gave out the FEMA website so that residents who receive letters from their insurance company regarding flood insurance would be able to read up on the issue.
- 3. **PECK** 'S comments:
 - **a.** School Resource Officer PECK and the Police Chief have met with the Superintendent and have come to an agreement that Sergeant Fairchild will be in the school; the school will be paying more than for the Patrol Officer but less than the amount of Sergeant Fairchild's wages.
 - **b.** Contributions Accountant Karla Carpenter has sent out letters to the individuals who gave contributions for Police uniforms and side arms. Due to some confusion, if anyone wanted to be reimbursed for their contribution all they have to do is contact Karla Carpenter at Flushing Township.
 - c. Paving of Carpenter Road Genesee County Road Commissioner John Daly and 7th District County Commissioner Archie Bailey met with residents that live on Tahquamenon Trail/Chickasaw Trail to discuss Carpenter Road. The estimate received to pave Carpenter Road was between \$700,000.00 and \$1,000,000.00. A recent bid was received back from the Road Commission for \$210,000.00 to pave Carpenter Road from McKinley Road to the River and to replace the curb and gutters as needed. During 2010, monies have been spent on Morrish Road, Johnson Road, and Deland Roads, for paving and gravel.

County Commissioner Archie Bailey will be setting up a meeting to see if there are other resources in order to obtain money to pave Carpenter Road. The meeting will be open to the public with elected officials to include Road Commission Director John Daly, County Commissioner Archie Bailey and Drain Commissioner Jeff Wright.
