WHEREAS, Daniel Borgerding is the record owner of the following described property located in the Township of Flushing, Genesee County, Michigan, described as:

Part of Lot 11 beginning South 40° 19' East 196.63 feet from Northwest corner of Lot 11, thence North 56° 57' 30" East 183.63 feet, thence South 70° 09' 30" East 9.85 feet, thence on curve to right - chord- South 58° 19' 39" East 871.38 feet, thence South 56° 16' West 169.44 feet, thence on curve to left- chord- North 58° 52' 25" West 766.63 feet, thence North 70° 18' West 88.35 feet, thence North 40°

The two (2) described parcels are hereinafter collectively referred to as the Properties; and.

WHEREAS the owners of record of the Properties, by letter (Exhibit 1) dated March 21, 2016, requested the City of Flushing to accept annexation of the Properties; and,

WHEREAS, the City of Flushing, by action of its City Council taken at its regularly scheduled meeting held August 8, 2016, accepted annexation of the Properties to the city, contingent on the appropriate approval of the Charter Township of Flushing; and.

WHEREAS Section 34 of the Charter Township Act, MCL 42.34(4) provides:

"... if a qualified elector does not reside in the territory proposed to be annexed that is contiguous to the city or village, other than the 1 or more persons petitioning, or if a petition signed by 1 or more persons... that collectively hold... recorded legal title to more than one half of the area of the land in the territory to be annexed is filed with the city or village and with the township board of the charter township in which the territory is situated, the annexation may be accomplished by the affirmative majority vote of the city council... of the city... and the approval of the charter township board of the township."; and,

WHEREAS the Properties are eligible for annexation as each is zoned commercial, each is vacant, no one resides or otherwise occupies either parcel and the Properties are contiguous to the City of Flushing; and,

WHEREAS the Properties may be more efficiently developed or otherwise used if administered in conjunction with property located in the City of Flushing; therefore,

IT IS HEREBY RESOLVED the Properties described herein are approved and authorized for annexation by the City of Flushing.

IT IS HEREBY FURTHER RESOLVED upon submission to the Charter Township of Flushing of a certified copy of a resolution of the Council for the City of Flushing accepting annexation of the Properties, the Properties shall be annexed to the City of Flushing and thereafter governed and administered as part of the City of Flushing.
