WHEREAS, Potter Road, between Elms Road and M-13 (Sheridan Road), serves as a boundary Road between the Charter Township of Flushing and the Charter Township of Clayton (collectively the Townships); and,

WHEREAS, due to its current condition, Potter Road requires repair and/or improvement; and.

CHARTER TOWNSHIP OF FLUSHING ORDINANCE NO.

At its regularly scheduled meeting held on Thursday, May 14, 2015, at 7:00 p.m. the Board of Trustees for the Charter Township of Flushing had the second reading of AN ORDINANCE TO AMEND SECTION 7 OF THE CODE OF ORDINANCES TO CLARIFY THE RESTRICTIONS APPLICABLE TO RECREATIONAL FIRES; TO DEFINE CLEAN WOOD; AND TO DEFINE CONSTRUCTION AND DEMOLITION WASTE AND TO PROHIBIT THE BURNING THEREOF

THE CHARTER TOWNSHIP OF FLUSHING ORDAINS:

Section 7-1, of Chapter 7 of the Charter Township of Flushing Code of Ordinances, generally "the Fire Ordinance", is amended by deleting the existing language in its entirety and replacing it with the following:

Clean wood means natural wood which has not been painted, varnished or coated with a similar material; has not been pressure-treated with wood preservatives; and does not contain resins or glues, as in plywood or other composite wood products. [Added]

Construction and demolition waste means building waste materials, including but not limited to waste shingles, insulation, lumber, treated wood, painted wood, wiring, plastics, packaging and rubble that results from construction, remodeling, repair and demolition operations on a house, commercial or industrial building, or other structure.[Added]

Open fire means any fire upon any woodlands, lots, subdivisions, grasslands, field or right-of-way within the Township not wholly contained within an incinerator, outside fireplace, grill or other receptacle constructed for and suitable to the purpose of burning of combustibles. [Unchanged]

Recreational fire means an outdoor fire contained within a fire ring or other suitable enclosure not to exceed twelve (12) square feet and in which is burned only clean wood and/or charcoal. The restrictions applicable to an open fire apply to a recreational fire, except for the time restrictions provided in Section 7-7(c). [Amended]

Section 7-5 of Chapter 7 of the Charter Township of Flushing Code of Ordinances is amended by deleting the existing language in its entirety and replacing it with the following:

- (a) The burning of construction and demolition waste as defined in Section 7-1 is not allowed under any conditions. [Added]
- (b) The burning of leaves and grass clippings is not allowed under any conditions. [Unchanged]
- (c) Only the burning of trees, logs, brush, and stumps is allowed under such conditions as specified in Sections 7-7 and 7-8. [Unchanged]

Except as expressly amended as stated above, all provisions of Chapter 7 of the Code of Ordinances remain in effect, unchanged by this ordinance.

This amendatory ordinance shall be effective immediately upon publication.

- 2. The Township Supervisor and/or Clerk are authorized to sign, on behalf of the Township, contracts or work orders to be prepared by the Genesee County Road Commission to provide labor and material for the repair of the above identified catch basin.
- 3. The total cost to be allocated under the contract to the Township for the repair of the Catch Basin shall be 50% of the actual cost of repair and the Township's share shall not exceed \$2,800, as set forth in the Catch Basin Cost Estimate which is attached and incorporated as part of this Resolution.
- 4. Authorization is granted for the Township's expenditure of an amount not to exceed \$2,800 for repair of one Catch Basin to be allocated to such budget line item as the Board determines.
