#### **DISCUSSION:**

It was unknown as to the type of equipment which Flushing Township would be receiving, although the equipment would be stored and maintained by the township in case of an emergency in Genesee County. Homeland Security deals with many issues; the grant would authorize the County to have control of items on behalf of Flushing Township.

Sheriff Pickell recommended the authorized signatories on the Homeland Security Contract be the Supervisor, Police Chief, and Fire Chief who would be the only individuals that could sign for Flushing Township to receive the equipment. The contract would not obligate the township; if Flushing Township decided to dispose of items, they could not be sold without the authority of the County.

When further details are available, the Board Members will be notified.

#### 1-m. Resolution to Prohibit Sunday Alcoholic Sales

**GARDNER MOVED**, seconded by Purkey to take no action.

#### **DISCUSSION:**

Attorney Steve Moulton (Attorney Moulton) stated that due to a recent change in a public act which amended certain sections in the Liquor Control Act, the Liquor Commission now has the authority to grant licenses for the sale of beer, wine, spirits, and mixed spirits on Sunday morning; currently alcohol can be purchased on any other day of the week starting at 7:00 a.m. On Sunday Morning you have to wait until 12:00 Noon to purchase alcohol.

The change in the law, which will become effective December 16, 2010, would allow the Liquor Control Commission to issue, to licensees, the right upon their request and payment of \$160.00, to engage in Sunday Morning sales.

The Act allows Municipalities, by resolution, to opt out of the act on or before December 15, 2010 and would not permit Sunday Morning liquor sales. The Commission will abide by the resolution awaiting further clarification of the law.

Currently, there are three (3) options for Flushing Township: 1) adopt a resolution to prohibit Sunday Morning liquor sales and the Liquor Control will recognize the issue; 2) adopt a resolution approving Sunday Morning liquor sales; or 3) do nothing. If nothing is done, the Liquor Control Commission will grant the licenses as requested. The new law, would allow liquor sales up until 11:59 p.m. Christmas Eve and Christmas Day after 12:00 Noon.

Although Flushing Township is considered a "dry community", the new law would allow people to apply for Sunday Morning Sales. It was felt there should be consistency across the State, the township should not get involved in a State law.

### **DISCUSSION:**

The Genesee County offices will be closed Thursday, December 23 and Thursday, December 30 and in the past, when the County was closed, Flushing Township was closed since the Township deals direct with the County on so many issues. The recommendation had been that the employees take a vacation day on Thursday, December 23, 2010 and the township would pay the employee wages on Thursday, December 30, 2010.

**PURKEY MOVED,** seconded by Matzke to allow the township to be closed both days, with the employees taking a vacation day for Thursday, December 23 and the township paying the wages for Thursday, December 30, 2010.

#### **DISCUSSION:**

It was questioned why the township would be closed on December 30; could the township pay the employees for the day and stay open on December 30, 2010 in order to better serve the residents. In the past Flushing Township has always been closed the same days as the County since transactions could not be taken care of with the County closed. The days off could be used as a bargaining chip for negotiations in the future; it was felt by a few that the office should be open on Thursday, December 30, 2010 in order to better serve the residents.

**GARDNER MOVED**, seconded by Minaudo to amend the motion on the floor to remove Thursday, December 30, 2010 as a closure date.

The office would be closed on Thursday, December 23, 2010 and the township employees would be using a vacation day; Thursday, December 30, 2010 would be open as a normal business day.

- 1. Treasurer's Report:
  - a. **Water Fund:** the water fund balance has grown by \$686,000.00; personally felt there should be some adjustments; ten (10%) percent is being charged for late water payment fees.
  - b. <u>Police Fund Balance:</u> negative balance of \$512,000.00 and have been advised to consult with Plante & Moran; future loans will come from the water fund, interest will be charged and the issue will be addressed later.
  - c. <u>Land Bank Property (Treasurer's Office</u>): three (3) properties are up to revert back to Flushing Township from the Land Bank Adelle Street, Duffield Road, and Frances Road.
  - d. **GASB 45**: the retirement funds have to be reviewed every three (3) years; there haven't been any large changes with money coming in or going out.

## 8:20 P.M. – OPEN FOR PUBLIC COMMENTS

Ten (10) people gave their opinions including Mr. Gordon Summers, 8083 Prestonwood Ct, Flushing, MI. Treasurer Noecker requested the following language be added to the Minutes of December 9, 2010; the Minutes were approved January 13, 2011:

"I, Gordon Summers, 8083 Prestonwood Ct, Flushing, MI, would suggest that each and every one of you stand up and pull your belt away, look down and see if you have the testicular fortitude to correct the problem."

#### 9:15 P.M. - CLOSED FOR PUBLIC COMMENTS

#### **BOARD COMMENTS:**

- 1. **MINAUDO** stated the rumor about the Chief being related to someone on the Board has been proven untrue so many times; there had been a question regarding postponing the appointments, but Minaudo only wanted time to absorb the recommendations.
- 2. **GARDNER** gave a scenario: "he heard this morning on the playground that Billy likes Susie; if this is true, please let him know."
- 3. **MATZKE** wished everyone a Merry Christmas and Happy New Year.
- 4. **PURKEY** wished all the employees a very Merry Christmas and Happy New Year; if people feel that the township is hiding money, they should go to the Attorney General otherwise accept what Plant and Moran has been telling the public.
- 5. **NOECKER** stated there was a lot of animosity and hatred at the board meeting.
- 6. **MORFORD** stated there would be another election on February 22, 2011 which would deal with the Montrose School District millage; only two (2) precincts would be effected; there will be a Michigan Township Association Genesee County Chapter Meeting at Atlas Township on Thursday, Dec 16, 2010 the speaker will be Jenifer Boyer, Emergency Management will be the speaker; Merry Christmas and Happy New Year.

## 7. SUPERVISOR COMMENTS:

- a. <u>Solid Waste Collection</u>: Flushing Township will be changing to Richfield Waste Services starting January 3, 2011; household waste and recycling will be collected every week; between April and November, yard waste will be picked up every week; the leaf collections in the subdivisions will be expanded. (a handout was available to the public in the foyer of the township hall).
- b. <u>Patrol Union</u>: The Flushing Police Department patrolmen have changed unions and are now with the Police Officers Labor Council (POLC); a letter was sent to the Patrolman from the Police Chief regarding hiring officers on a part time basis with regular pay; the officers would like to negotiate including setting up a committee various information including the budgets have been given to the officers for their review.
- c. <u>Genesee County Road Commission</u>: the 50/50 road funds for 2011 have been sent in and the township will receive \$21,340.00 for roads; roads will be discussed at the January 2011 Board Meeting.
- d. <u>Meetings</u>: in the past, roll call votes have been taken for every action, but in the future only issues dealing with money and closed sessions will require a roll call.
- e. <u>Closing of the Office:</u> it is the right thing to do for all the employees; Merry Christmas to everyone.

Hopes the township can come to some type of solution; the Supervisor will not vote to raise taxes in any way unless the people of the township vote – either way he will be for the people.
